	<p>This is an important issue and this would apply to UK families as well. There would be an additional administrative element added to the HMBC if they were to do this and would this operate on a case by case basis. In addition, if we started to take general donations, HMBC would need to then register with the Charities Commission and go through auditing processes which would further add the administrative burden to the organisation. A sister organisation/committee could be formed to operate the emergency funding element.</p> <p>Alternatives could include families to loan money to those that cannot afford burials.</p> <p>Policies and governance need to be considered to ensure that we are able to maintain transparency and provide a service that is suitable. That way fundraising can be conducted through means like crowdfunding where caps are in place to ensure excess is not collected.</p> <p>Options need to be considered on how we decide to progress as an organisation</p> <p>C.
